RELEASE OF LIABILITY/INDEMNIFICATION

In consideration for the privilege of using the Tri-City Police Academy Facilities, including but not limited to: buildings, exercise equipment, gun range, obstacle course, driving pad and during Simunitions Training, I hereby agree to waive, release, defend, indemnify, hold harmless, and discharge the City of Plano and the City of Richardson from any and all claims for damages for death, personal injury or property damage, which I may have, or which may hereafter accrue to me, as a result of my use of the Facilities. This Release is intended to discharge in advance the City of Plano and the City of Richardson, their respective officers, officials, employees, agents, representatives or any other third party for whom each respective City is legally responsible, (collectively "RELEASEES"), from and against any and all liability arising out of or connected in any way with my use of the Facilities, even though that liability may arise out of negligence or carelessness on my part or on the part of the persons or entities mentioned above. This Release is contractual and is given in consideration for the use of the Facilities.

I further understand that serious accidents may occur during the use of the Facilities and that participants may sustain mortal or serious personal injuries, and/or property damage, as a consequence thereof. Knowing the risks of participation, I nevertheless, hereby agree to assume those risks and to release, indemnify, defend and hold harmless all of the persons or entities mentioned above who (through negligence or carelessness) might otherwise be liable to me (or my heirs or assigns) for damages. It is further understood and agreed that this waiver, release, indemnification agreement and assumption of risk is to be binding on my heirs and assigns. I agree to release, defend, indemnify and hold harmless RELEASEES from any and all such claims by my heirs, successors and assigns. I agree to accept and abide by the rules and regulations of the City of Plano and the City of Richardson for use of the Facilities.

Further, I do hereby agree to waive all claims, release, indemnify, defend and hold harmless RELEASEES, in both their public and private capacities, from and against any and all liability, claims, losses, damages, suits, demands or causes of action including all expenses of litigation and settlement, court costs and attorney fees which may arise by reason of injury to or death of any person, including but not limited to any and all third parties, or for loss of, damage to, or loss of the use of any property, including but not limited to that of any and all third parties, occasioned by error, omission, or negligent act of myself, RELEASEES, subcontractors, invitees or any other person, arising out of or in connection with use of the Facilities.

It is to be emphasized that disruptive conduct or conduct unbecoming a police officer will not be tolerated.

If any of the terms, sections, subsections, sentences, clauses, phrases, provisions, covenants, conditions or any other part of this Release are for any reason held to be invalid, void or unenforceable, the remainder of the terms, sections, subsections, sentences, clauses, phrases, provisions, covenants, conditions or any other part of the Release shall remain in full force and effect and shall in no way be affected, impaired or invalidated.

Nothing in this agreement shall constitute a waiver of any defense available to the RELEASEES.
