## *Building a Hate Free Community*

- **R = Respect/Responsibility**
  - *To respect another person's right to have opinions and thoughts that is different from yours.*
  - *To take responsibility for your own learning.*

## *Building a Hate Free Community*

- **O = Openness/"Oops"/"Ouch"**
  - *To considering alternative thoughts, ideas, opinions and behaviors.*
  - *When you may unintentionally say something and wish you had not.*
  - *When someone's words or actions may hurt you.*

## *Building a Hate Free Community*

### • ***P = Participation/Pass***

- *In the program activities and discussions.*
- *“The more you give, The more you get”*
- *When you so choose*

## *Building a Hate Free Community*

### • ***E = Education/Escuchar***

- *Is an ongoing process. “Enlarge your knowledge about yourself and others while expanding your diversity skills.”*
- *Listening is more than just hearing others. “Clarify your understanding with questions that will lead you to awareness!”*

## *Building a Hate Free Community*

- ***S = Sensitivity***

- *To the feelings of others.*
- *“Keep private information confidential. Be careful with your words and deeds and be responsive to feedback from others.”*

## *Defining Hate Crime*

***A CRIMINAL OFFENSE COMMITTED AGAINST A PERSON WHICH IS MOTIVATED, IN WHOLE OR IN PART, BY THE OFFENDER’S BIAS AGAINST A RACE, RELIGION, DISABILITY STATUS, ETHNICITY/NATIONAL ORIGIN, GENDER OR SEXUAL ORIENTATION.***

***DIFFERENT STATES HAVE VARIOUS CATEGORIES FOR HATE CRIME LAW. SOME MAY INCLUDE THE CATEGORIES GENDER IDENTITY, AGE AND, OR POLITICAL AFFILIATION.***

## ***Hate Crimes/Hate Incidents***

◆ ***A HATE INCIDENT IS AN ACT OF CONDUCT, SPEECH, OR EXPRESSION TO WHICH A BIAS MOTIVE IS EVIDENT AS A CONTRIBUTING FACTOR (REGARDLESS OF WHETHER THE ACT IS CRIMINAL).***

◆ ***A HATE CRIME IS A HATE INCIDENT THAT HAS RISEN TO THE LEVEL OF A CRIME. ALL HATE CRIMES ARE HATE INCIDENTS, BUT NOT ALL INCIDENTS ARE CRIMES.***

## ***Defining Hate Speech***

◆ ***DESCRIBES THE PERCEIVED INFERIORITY OF THE TARGETED GROUP BY DEFINING OR BELITTLING THEIR HUMANITY.***

◆ ***IS DIRECTED AT A PERSON OF A DIFFERENT IDENTITY GROUP AND INCLUDES REFERENCE TO THESE DIFFERENCES WITH THE INTENT TO CAUSE DISTRESS.***

◆ ***TYPICALLY CONTAINS RECOGNIZABLE SLURS AGAINST THE TARGETED GROUP.***

## ***Exceptions to 1<sup>st</sup> Amendment Speech Protections***

- ◆ ***SLANDER, LIBEL***
- ◆ ***PORNOGRAPHY, OBSCENITY***
- ◆ ***FIGHTING WORDS***
- ◆ ***CAPTIVE AUDIENCE SPEECH***
- ◆ ***CLEAR AND PRESENT DANGER TO PUBLIC SAFETY***
- ◆ ***NATIONAL SECURITY***
- ◆ ***FALSE AND DECEPTIVE ADVERTISING***
- ◆ ***WHERE SPEECH IS INCIDENTAL TO CONDUCT***
- ◆ ***SOLICITATION CRIME***
- ◆ ***WORDS USED WHICH TEND TO PROVE  
DISCRIMINATORY MOTIVE***
- ◆ ***RACIAL, RELIGIOUS, AND SEXUAL HARASSMENT IN  
SCHOOLS AND WORKPLACE.***
