Financial Affidavit for F-1 and J-1 Students

The Department of Homeland Security (DHS) requires that all F-1 and J-1 students show proof of financial support for each year of university study in the United States. In order to meet this requirement, all F-1 and J-1 students must submit:

- 1) a financial affidavit signed by the student and personal sponsors.
- 2) a bank statement or other comparable evidence of financial stability. This document must be current within the last 6 months and on letterhead.

The current minimum amount required per academic year is **\$33,910 for an undergraduate student or \$30,585 for a graduate student** (add \$5000 if you plan to sponsor your spouse and \$3000 for each child you plan to sponsor). These amounts are estimated costs of attendance based on shared housing and use of public transportation. Exact costs vary by student. The estimates are subject to change without prior notice. Please note: you are likely to need original copies of all documentation when applying for a visa with the United States Consulate or Embassy.
