## Master of Science in Accounting



### Curriculum

The Master of Science in Accounting degree program provides a tailored educational experience that encourages:

- A globally oriented, interdisciplinary focus.
- A balanced conceptual and pragmatic approach.
- Development of written and oral communication skills.
- Refinement of research and analytical skills that results in enhanced decision-making abilities.
- A commitment to lifelong learning.



The program prepares leaders to develop the professional skills identified by the Institute of Certified Public Accountants deemed essential for providing the core accounting services across various fields, including corporate accounting, assurance services, taxation, internal audit, government/nonprofit, and ERP/SAP systems. Upon completion of the program, students may be eligible to sit for the Uniform CPA Exam, provided they meet the requirements of each state's board of public accountancy. ### Program Options

MS Accounting Flex allows students the flexibility to complete the program at their own pace and tailor their degree according to their career goals by selecting electives from various fields. Courses are offered in the daytime, evenings and online. Admission to the program occurs in fall, spring and summer semesters. MS Accounting Cohort is a two-year program in which students take all courses together as a cohort. Admission to the program occurs only in the fall semester.

### Career Options

Graduates of the program seek positions in various fields such as: management accounting in public or private sectors, financial planner, financial analyst and other careers in taxation and external/internal auditing services. Upon completion of the MS in Accounting degree program, students may sit for the Uniform CPA Examination, provided they meet the requirements.

### Degree Program
