5	Admissions Criteria(most recent year)	Provide a description of key admission factors.	<p><b>1)</b> The deadline for submission of all application materials for fall admission is the preceding December 1.</p> <p><b>2)</b> Admission to the doctoral program is based on review of the applicant's GPA, GRE scores, letters of recommendation, and narrative description of research interests and goals. The admissions committee weighs heavily the match between the applicant's research interests and the research areas available to students in the school. At the time the student enrolls, the test score must be less than 2 years old. The minimum TOEFL score for admission is 80 (internet-based test). The minimum IELTS score is 6.5.</p>
